<b>Driving History – Major</b>	No disqualifiers unless felony	None in the past 7 years: DUI or drugged driving, speeding 100+ MPH, hit & run, reckless driving street racing	None in the past 3 years: Attempting to elude police, reckless driving, driving on a suspended or revoked license
<b>Criminal</b>	Within 10 years, felony conviction of: <ul style="list-style-type: none"> <li>• Kidnapping</li> <li>• Unlawful imprisonment</li> <li>• Custodial interference</li> <li>• Homicide</li> <li>• Sex offenses</li> <li>• Indecent exposure-prostitution</li> </ul> Within 5 Years conviction of: <ul style="list-style-type: none"> <li>• Any other felony</li> </ul>	Within 7 years conviction of: <ul style="list-style-type: none"> <li>• Any felony</li> <li>• Any driving related offenses</li> <li>• Violent crimes</li> <li>• Sexual offenses</li> <li>• Child abuse or endangerment</li> </ul>	Within 7 years conviction of: <ul style="list-style-type: none"> <li>• Any class A or B Felony per RCW 9A</li> <li>• Any violent offense or serious offense per RCW 9.94A.030</li> <li>• Any sex offense per RCW 9.94A.030</li> <li>• DUI, hit &amp; run, or any other driving-related crime</li> <li>• Sex offender in national database</li> </ul>
<b>Insurance Requirements</b>	<ul style="list-style-type: none"> <li>• Combined single limits of \$300,000 or split limits of minimum \$100,000 for personal injuries to one person</li> <li>• Minimum \$300,000 for personal injuries caused by any one accident</li> <li>• Minimum \$50,000 for property damage caused by any one accident</li> <li>• Underinsured and uninsured motorist insurance</li> </ul>	<ul style="list-style-type: none"> <li>• \$1 million combined single limit per incident</li> <li>• \$50,000 bodily injury per person</li> <li>• \$100,000 bodily injury per accident</li> <li>• \$30,000 property damage per accident</li> <li>• \$1 million uninsured/underinsured bodily injury per incident</li> </ul>	<ul style="list-style-type: none"> <li>• \$1 million combined single limit per incident</li> <li>• \$50,000 bodily injury per person</li> <li>• \$100,000 bodily injury per accident</li> <li>• \$30,000 property damage per accident</li> <li>• \$1 million uninsured/underinsured bodily injury per incident</li> </ul>
