ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Pullman for January 1, 2008, through December 31, 2008.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit:

- Billings/receivables
- Cash receipting
- Donations/fundraising
- Open public meetings/records laws
- Disbursements/expenditures
- Payroll/personnel
- Conflict of interest/ethics laws
- Compliance with grant requirements

RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE CITY

Incorporated on April 11, 1888, the City of Pullman currently serves approximately 27,150 Whitman County residents. The City is governed by an elected, seven-member Council with a separately elected Mayor. Its 300 employees provide an array of services including police, fire, ambulance, water supply treatment and distribution, sewage treatment and collection, street maintenance, transit, planning and zoning and public facilities such as a library, parks and recreation and cemeteries. For fiscal year 2008, the City operated on a budget of approximately \$41 million.
